☐	U.S. Permanent Resident After we receive your document, we will submit to the Department of Homeland Security (DHS) for verification of your status. It can take up to 8 weeks for DHS to respond.	Upload ONE of the following, along with a copy of a valid government-issued photo identification card bearing your portrait or likeness, and this completed form: • Alien Registration Receipt/Resident Alien/Permanent Resident/Conditional Permanent Resident card (I-551, I-94, I94A) • Foreign passport with I-551 endorsement • Arrival/Departure Record I-94 with I-551 endorsements
☐	Other eligible non-citizen I-94 designated as: "Refugee" "Asylum Granted" "Parolee" "Cuban-Haitian Entrant" or "Conditional Entrant"	Upload the documentation that applies to you, along with a copy of a valid government-issued photo identification card bearing your portrait or likeness and this completed form: • Arrive/Departure Record (I-94, I94A or I-571 with proper endorsements). Note: "Parolee" must be paroled for at least one year, and you must ALSO provide evidence from the USCIS that you are in the United States for other than a temporary purpose with the intention of becoming a U.S. citizen or permanent resident): • Application to Register Permanent Residence or Adjust Status (I-485) & Notice of Action (I-797) • Petition for Alien Relative (I-130) After we receive your documents, we will send them to the Department of Homeland Security (DHS) for verification of your status. ☐	Victim of Human Trafficking -OR- Battered immigrant-qualified alien	Upload ONE of the following, along with a copy of a valid government-issued photo identification card bearing your portrait or likeness, and this completed form): • Copy of your eligibility letter from Health & Human Services (HHS) or a T-visa • Copy of your I-797, Notice of Action form from US Citizenship & Immigration Services (USCIS), with a valid expiration date verifying financial aid eligibility.
