A small team visit will follow submission of the report. The next evaluation visit is scheduled for 2015-2016.

To accept the Periodic Review Report and to reaffirm accreditation. To request a monitoring report, due September 1, 2012, that (1) documents clear statements of expected student learning outcomes at the institutional, general education, and program levels (Standard 14), (2) documents direct, systematic evidence of student achievement of those institutional, general education, and program-level outcomes (Standard 14), (3) documents explicit, systematic use of direct as well as indirect evidence of student achievement of those institutional, general education, and program-level outcomes to improve teaching and learning (Standard 14), and (4) documents systematic evidence of further steps taken to improve student retention and graduation rates. A small team visit will follow submission of the report (Standard 8). To direct an

immediate Commission liaison guidance visit to discuss the Commission's expectations. The next evaluation visit is scheduled for 2015-2016.

January 3, 2011

To acknowledge receipt of the substantive change request, and to include the reclassification of the instructional site at Conwell-Egan High School, 611 Wistar Road, Fairless Hills, PA, to an additional location within the scope of the institution's accreditation. To remind the institution that the Periodic Review Report, due June 1, 2011, should document (1) implementation of an organized and sustained process to evaluate achievement of institutional mission and strategic goals (Standard 7), and (2) direct evidence of student achievement of institutional, general education, and program-level learning outcomes (Standard 14).

November 20, 2008

To thank the institution for receiving the Commission's representatives. To remind the institution that the Periodic Review Report, due June 1, 2011, should document (1) implementation of an organized and sustained process to evaluate achievement of institutional mission and strategic goals (Standard 7) and (2) direct evidence of student achievement of institutional, general education, and program-level learning outcomes (Standard 14).

June 22, 2006

To reaffirm accreditation, to commend the institution for progress to date, and to request a progress letter, due April 1, 2008, on (1) implementation of a long-term financial plan that is aligned with the institution's mission, goals, and strategic plan, (2) implementation of a documented process to assess the achievement of institutional goals, including those for student learning, and steps taken to use assessment results to improve programs, services, processes, planning, resource allocation, teaching and learning, and (3) steps taken to develop a comprehensive staffing plan for full-time faculty. The Periodic Review Report is due June 1, 2011.
